Motion to approve made by Councilman Maccaroni, seconded by Council President Bilella. All members present were in favor.

PRIVILEGE OF FLOOR:

Paul Canfield - 15 Haines Avenue – Mr. Canfield expressed his concerns about the bus company parking their buses all along the property line. The exhaust fumes are coming into his yard and they are using residential property for commercial use. Mayor Armano asked the bus company to park on the lot due to renovations. Property Maintenance will go over to the bus company and speak with them.

COMMITTEE REPORTS:

MAYOR ARMANO reported that municipal court will be moved to Waterford Twp November 15th due to renovations being done on the municipal building; Discussion about the shared services agreement resolution on the agenda – opening up the agreement to include Clementon Borough; Have not heard anything back from the representative from the Governor's office that came to observe the traffic on Taunton Avenue and the White Horse Pike and Franklin Avenue and the White Horse Pike.

BUILDINGS & GROUNDS, Chairman Gary Knight reported that exterior lighting at the library has been replaced; Fall cleanup has been in progress and the heating systems are being checked; DPW put in the new lockers at the police station last week.

STREETS & ROADS, Chairman James Bilella provided an update on the building project. Once court is moved to Waterford Twp we will start construction and renovations on the municipal building. The parking lot has been partially paved as well; Malan Avenue was paved on Friday and the next road program project will focus on Taunton Avenue and the White Horse Pike up to the railroad tracks. That should be done in early spring and the design portion will be addressed over the fall; There was discussion about the resolution on the agenda in regard to the completion of Taunton Avenue.

WATER & SEWER, Chairman Lynn Kupchik discussed Resolution R10-1 which has to do with the beginning of the process of the pipeline rehabilitation; September 30th was the end of collections for the water and sewer bill for the third quarter. The total amount collected was \$740,089.28; There were 530 water shutoff's and none of them were in Berlin Borough; About 176 residents have outstanding water bills.

HEALTH & RECREATION, Chairman Jim Pearce reported that the soccer association had their grand opening for their season; the softball fields behind the community center needs dirt (Councilman Pearce was contacted by Debbie Simone and she informed him that someone was injured due to the lack of dirt); Mayor Armano suggested that DPW Superintendent Mark Mauger be contacted to take care of the dirt and the leveling; There has been an ongoing issue with the capacity limit at the community center and Councilman Pearce would like to a get a number from the Fire Marshall.

PUBLIC SAFETY, Chairman Scott Scelso provided a report on the police department for the month of August. The department handled 1,858 calls for service. 411 summonses were issued along with 34 arrests, 8 DWI arrests, 17 warrant arrests and 12 drug arrests. 9,245 miles were put on the police vehicles during patrol and other duties. 36 motor

vehicle accidents were reported with 8 resulting in injuries. A full report is attached to these minutes; The fire department had 55 calls for the month of August; The ambulance had 217 calls-91 were for Berlin Borough and 89 were for Berlin Twp; Resolution R10-25 is on the agenda to approve Nixle the notification system which will be up and running very soon.

FINANCE, Chairman Nick Maccaroni reported that after lengthy discussion with the CFO and Treasurer we have decided to stay with paychecks every week rather than biweekly; We will address it again next year; There is a resolution on the agenda tonight stating that it is mandatory that all employees enroll in direct deposit; Part of Washington Avenue will be dedicated to Walt McKeever on October 18th during the Fall Fest at the Fire Hall and his family will be in attendance. Walt will be turning 100 years old.

SOLICITOR, George Botcheos did not have anything to report.

ADMINISTRATOR, Charleen Santora reported Ollie Gator's is going to sponsor a beer garden at the Fall Fest. She and Chief DeLorenzo have to sign off on a permit application that is approved by the state so that Ollie Gator's is in compliance. Also, Ollie Gator's is naming Berlin Borough additionally insured; There was discussion on resolutions that are the agenda for approval; Borough offices are closed Monday, October 13th in observance of Columbus Day.
