OLD BUSINESS:

Case # 14:10-2 Eric Coburn 34 E. Taunton Ave. Block: 1400 Lot: 23 Minor Subdivision Mr. Rinaldi stated on the record that Mr. Guerere signed a prepared affidavit that he listened to the tape of the November Planning Board hearing for this application and is now able to vote on this application. Said affidavit will be in the file located in the Planning and Zoning office. Appearing before the board Eric Cobourn, applicant. Mr. Cobourn requested to withdraw his application for this subdivision. The board confirmed with Mr. Cobourn, and the application is withdrawn.

NEW BUSINESS:

Case# 14: 12-1 Eric Coburn 34 E. Taunton Ave Block: 1400 Lot: 23 Bulk C Variance

Appearing before the board is Eric Cobourn. Mr. Cobourn testified that he purchased the property at 34 E. Taunton Avenue, and tore down 2 dilapidated sheds. He replaced one shed on the existing foundation, and added crushed stone over the existing concrete pad. The new shed is larger than the original structure. Mr. Cobourn submitted exhibits A through C which are photos of the new structure. Mr. Rinaldi commented if the structure is a shed or a garage. Mr. Cobourn testified that there are no utilities, there will be no driveway, and no motor vehicles stored. Mr. Rinaldi explained to the board they need to decide if this structure will be considered a shed or a garage. Mr. Hall asked if this is considered a shed, can the board restrict the usage to no vehicular storage. Mr. Rinaldi stated yes. Mr. Hall asked about the fence and where the proposed fence would be. Mr. Cobourn stated the proposed fence would run parallel with the adjoining fence, and cross to the house with no gate. Mr. Cobourn added that he chose a larger shed for storage to avoid having multiple sheds on the lot and keep with a historical look. With nothing further from the board, Chairman Gangluff opened this portion of the meeting up to the public. With no one from the public wishing to speak on this application, the public portion was closed.

Mr. Rinaldi summarized the application, and Mr. Hall made a motion to approve the application as a shed with a side yard variance of 14 feet where 20 feet is required, and with conditions that there will be no utilities, no driveway, and no storage of motor vehicles. PUBLIC PORTION:

Appearing before the board is Michael Iluicci of 191 Clementon Road. Mr. Iluicci addressed the board by stating it is his intention to build a garage and would like to change his address to Maine Avenue, as he is building an addition, and the front of the house will face Maine Avenue. Direction was given by the board to Mr. Iluicci to come to the zoning office with a survey and a plan and the zoning officer will assist in direction of what the set backs are and what will be permitted.

GOOD OF THE ORDER:

Chairman Gangluff mentioned that if anyone on Borough Council has questions regarding any application, to please call him, and he suggested that members of Council attend Planning Board Meetings. Mr. Hall asked that relative to applications that have not been heard, what the Planning Board Members are permitted to discuss and what cannot be discussed. Mr. Rinaldi informed the board that no pending application can be discussed at all outside of the actual hearing. Members are encouraged to contact the Planning and Zoning office, or the Attorney for the board. The application cannot be discussed unless it is completed, with a signed resolution.

Mr. Rinaldi addressed another matter regarding Luciens and an approved resolution for a Use Variance for a Church and a Bakery in the KB Properties strip store lot. Mr. Kolovos is requesting amending the resolution/application to permit the bakery to be open on Sundays. There was discussion regarding the parking at that time, and currently the Church occupies the space with 80 seats available. The board has requested that Mr. Jim Biegen verify the actual parking, Mayor Armano stated by what he has observed is that there are not many cars in the parking lot. Mr. Hall mentioned that the board voiced a concern and by his recollection that the board decided what the Church will be in the future, not what it is today, so regarding parking, we decided full capacity at parking what the overall potential would be. Chairman Gangluff stated we had limited information at the time of the application. Chairman Gangluff added that we may need more information as to what the hours would be and get confirmation from our Engineer as to what the actual parking is for the Church and what it would be for the Bakery as

well as including any overflow parking from Luciens. Mr. Rinaldi will send the Attorney for Mr. Kolovos a letter explaining the boards actions.

Mayor John Armano made a motion to obtain more information from the Engineer to verify parking, and make an administrative decision, however we would need some type of letter, and Carl Canfield Jr. seconded the motion. On roll call vote:
