ORDINANCE NO. 2012-08

AN ORDINANCE AMENDING AND SUPPLEMENTING
CHAPTER 218 OF THE CODE OF THE BERLIN
ENTITLED "MERCANTILE LICENSES"

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF BERLIN, COUNTY OF CAMDEN, STATE OF NEW JERSEY, AS FOLLOWS:

SECTION 1. Chapter 218, Section 16, of the Code of the Borough of Berlin entitled "Fee Schedule," is hereby amended to read as follows:

SECTION 2. Chapter 218 of the Code of the Borough of Berlin is hereby amended and supplemented by the addition of a new Section 218-16.1 entitled, "Late Fee," as follows:

§ 218-16.1. Late fee.

Licensing fees are due and payable on or before July 1st annually. Mercantile licensing fees not paid on or before July 1st annually shall be subject to a late fee of \$30.

SECTION 3. Chapter 218, Section 17, of the Code of the Borough of Berlin is hereby amended to read as follows: All businesses, trades and activities which have not been classified in the license fee section of this chapter, for each location, shall pay a license fee of \$60."

SECTION 4 All ordinances or parts of ordinances which are inconsistent with the provisions hereof, are, to the extent of such inconsistencies, hereby repealed.


SECTION 5 This ordinance shall take effect upon final passage, adoption, and publication in the manner prescribed by law.
