

**BOROUGH OF BERLIN  
SALARY ORDINANCE 2014-04**

**AMENDS SALARY ORDINANCE 2013-01 AND 2013-07 SUPPLEMENTING  
CHAPTER 62 OF THE CODE OF THE BOROUGH OF BERLIN ENTITLED  
"SALARIES".**

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF BERLIN,  
CAMDEN COUNTY, STATE OF NEW JERSEY, AS FOLLOWS:

**SECTION 1.** Chapter 62, subsection 1, of the Code of the Borough of Berlin is as follows: The salary of the Mayor of the Borough of Berlin is hereby fixed and determined at \$6428.75 per annum.

**SECTION 2.** Chapter 62, subsection 2, of the Code of the Borough of Berlin is hereby as follows:

- A. The salary of each member of the Borough Council of the Borough of Berlin is hereby fixed and determined at \$2500.00 per annum.
- B. The salary of the President of the Borough Council is hereby fixed and determined at \$2848.80 per annum.

**SECTION 3.** Chapter 62, subsection 3, of the code of the Borough of Berlin is hereby amended to read as follows:

Said salaries shall be effective, subject to the provisions of statute referred to, as of January 1, 2014. Said salaries shall be paid at the time and in the same manner as may hereafter be determined by the Borough Council of the Borough of Berlin.

**SECTION 4.** Chapter 62, Subsection 5, of the Code of the Borough of Berlin is hereby amended to read as follows:

- A. The annual salaries of the following officers and employees of the Borough of Berlin hereinafter named, be and the same are hereby fixed, effective January 1, 2014, as follows (certain salaries are stated as hourly or other rates):



**SECTION 8.** This ordinance shall take effect immediately after final passage and publication as provided by law, and the salary schedule shall continue in effect, beginning of January 1, 2014 unless otherwise provided by law.
