**ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 67 OF THE CODE OF  
 THE BOROUGH OF BERLIN, COUNTY OF CAMDEN, STATE OF NEW JERSEY  
 ENTITLED "WATER RATES"**

WHEREAS, Chapter 67 of the Code of the Borough of Berlin is to be updated per the chart below

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Borough Council of the Borough of Berlin as follows:


**Section 1:** Chapter 67 of the Code of the Borough of Berlin, Section 4, is deleted in its entirety and is replaced by a new Subsection 4, increasing water rates for quarterly charges based on the meter size and charges based on gallons consumed, as follows:
