# PRIVILEGE OF FLOOR:

Cynthia Jennings, 26 Glacier Drive, Berlin.

Presented questions from Longaconing home owners asociation. Asked the council if speeding can be controlled through Lonaconing East by the borough. Chief DeLorenzo will look into this. Asked if a no parking sign can be installed on Glacier Drive in certain areas. Mayor states any no parking signs would have to be approved by ordinance. Mayor will have engineer look into. She questions if there is a time limitation on performance bonds and how long it can go on. Questions any update on the widening of Berlin Cross Keys Road. Councilman Scelso suggests that Cynthia advise all of the residents in her area about speeding and they may be ticketed regardless of them living on that street.

Tom Little, 4 Thackara Avenue, Berlin.

He and some residents are requesting speed bumps be put on Thackara Avenue like they were put on Haines Avenue due to speeding. Mayor explained that the speed bumps were put on Haines with the recent road program that was just repaved being the first time this has been done. We will look at bumps in different areas when streets are repaved if necessary. Councilman Maccaroni reiterated that speed bumps were put on Haines with engineering planning to coincide with draining, etc.

COUNCIL/DEPARTMENT HEAD REPORTS:

CHIEF OF POLICE MICHAEL DELORENZO

Chief DeLorenzo gave his report. Attached to these minutes.

**COUNCIL MEMBER'S REPORTS:** 

MAYOR JOHN J. ARMANO: Capital budget meeting held today in an effort to come up with 2013 purchases including the building of a new police station and a new trash vehicle. According to CFO, revenues are down so far this year. Construction is down and court is up therefore it could possibly offset he reports. /Recycling numbers are up 20% from last year and

tipping fees are down 4% from last year making a savings of approximately \$7000. as of now./Mayor explains the League of Municipalities is supporting Assembly Bill A 2681 for the extensions of the statute of limitations from two years to seven years on law suits to public bodies and the elimination entirely on the actual predator whereas bill no A2405 and Senate Bill 1651 is a bill to have the statute indefinitely. He is asking for this resolution to be put on this agenda making it R9-17; 2012.

Solicitor Rinaldi explains that the supporting of this bill is the right direction the municipalities should take.

BUILDINGS & GROUNDS, Councilman Scelso met with Superintendent of the Berlin Community School and a figure was agreed on for the lighting detection system. Resolution on agenda R9-14 suggesting the approval of \$3675.00 for the borough's portion. /16 Haines is moving forward. Still waiting for all of the utilities to be shut off or removed. /He will be at the soccer field on Saturday representing the borough for the Berlin Eastern Soccer Association.

WATER & SEWER, Chairman Lynn Kupchik Estimated water bills were sent out due to radio meter reading system still being down./Well # 15 is still being worked on with utilization of it being projected by next spring./She will have water capital need projection within weeks./The 4<sup>th</sup> annual fall festival will be on 9/29. Forms are in borough hall. Festivities include a trolley tour, dog parade, food vendors, and arts and crafts. VFW will sponsor a table.

STREETS & ROADS, Chairman Jim Bilella. Jim states that speed bumps cost \$6000. each for Haines Avenue and were figured in with the entire road project. Speed bumps would be costly if put throughout the entire borough./Two resolutions on agenda from Birdsall Engineers for the design of Ellis Avenue and for the application of a grant from the DOT for Malan Avenue.

HEALTH & RECREATION, Chairman Jim Pearce checking with the new President of the Berlin Rotary to see if the Rotary would be willing to purchase a defibrillator for the community center. /Berlin soccer would like to purchase a flag pole but are concerned about it needing lighting. /Sign for the community center for the sponsors has been ordered from Walter Signs. /Health screening will be held on 9/8 at the community center.

PUBLIC SAFETY, Chairman Dennis Chance gave a report for the month of July for the fire department and ambulance all attached to these minutes.

FINANCE, Chairman Nick Maccaroni. Questioned where the court is on the collecting of old fines, etc.

SOLICITOR, George Botcheos was absent.

ADMINISTRATOR, Charleen Santora advised council that there is a meeting scheduled 9/12 in Mays Landing for a possible rate increase for Atlantic City Electric./Asked that anyone needing a badge for the convention to purchase the badge and will be reimbursed right afterwards./Assessor will be at the next council meeting for questions from council./All lighting has been installed in regards to the clean energy program.
