PRIVILEGE OF FLOOR:

Roy Schmidt, Hamilton Avenue, Berlin.

Mr. Schmidt questions what is happening with 16 Haines Avenue building as he feels it is in disarray. Councilman Scelso states his committee had looked into renovating for police, however, not all of council was on board due to the cost. There was also discussion on knocking it down. He will look into doorway that needs repair. Scelso states the most economical way is being looked into.

Mr. Schmidt states there are several areas at the hotel that need attending plus several windows need glazing. Mayor Armano states the windows are being glazed according to their need by Berlin Glass. He would like to see the utility room less cluttered. Mr. Schmidt stated the railroad station is being used as a dumping area and would like to see it kept better.

Paul Iacovoni, an Eagle Scout from Berlin is working on a merit badge and has offered to paint the railroad station along with his family. He has a list of material he will need and was asked to see the borough administrator for the money encumbrance. Also for insurance information. He stated the cost should be no more than \$130.00 for supplies and \$650.00 for paint. The council thanks Paul volunteering for this job.

Brenda Roland, 39 Joans Lane, Berlin.

Ms. Roland has a huge concern regarding graphic graffiti on the back of the old ACME she feels has a meaning that is cause for concern. Mayor states Lt. Beasley has made a call to the owner of property for them to remove. If this does not happen, the borough will have DPW paint over it no later than Friday of this week Armano states.

# **COMMITTEE REPORTS:**

MAYOR ARMANO Franklin Avenue repaving will start 10/10/2011 with an estimated completion date of 11/2/2011. Street will be open on weekend and nights when no construction is being done. School aware of construction. Walkers have been re-routed to and from school from one side of street to another, depending on completion of sidewalks. /Clock at PNC bank is under construction.

BUILDINGS & GROUNDS, Chairman Scott Scelso. Wood has been replaced at the Berlin Hotel. Exterior is being painted regularly. He will take care of his concerns. /Looking into new carpet at borough hall. /Looking into higher speed bumps for parking lots around borough hall, library and hotel. /131 So. White Horse Pike has been completely gutted. Seeking prices for electric. /Compressor still on order for municipal building for central air. /No major damage from hurricane Irene.

STREETS & ROADS, Chairman James Bilella. Road program starting for Arlington and Haines. Sub-contractor hired for the cutting down of trees did some damage on Haines Avenue on private property and to water and sewer line that has been resolved with the contractor and engineer. He met with resident and Mayor Armano met with engineer and contractor. Curbing and sidewalk will be next phase. /Grant application has been submitted for 2012 for Ellis and Washington Avenues with program completion of Haines next year.

WATER & SEWER, Chairman Lynn Kupchik Additional engineer reports have submitted for well # 15 to the DEP./No water turn on's or off's./Two pumps went for the sewer department. Pump borrowed from Berlin Township. She is suggesting that we put in x amount of pumps each year due to the ages of these pumps to save and avoid overtime when we get a breakdown.

HEALTH & RECREATION, Chairman James Pearce. Changes made on Community Center ordinance that is on agenda. /Met with Berlin Soccer Club and they need clarification as to who owns the soccer fields. Mayor Armano researched the fields and found soccer fields are on Block 907 lot 1.01 owned by Berlin School so any improvements would have to go through the school done by the soccer team. The community center Armano states is on Block 518, lot 1 owned by the borough. Fields behind community center belong to the borough and are the responsibility of the borough. Pearce offers our help in anything the organization needs help for in trying to obtain a grant. Borough fertilizes and cuts all fields whether owned or not. New ordinance on agenda notes that there will be a designated person named for all events. He will talk to Admin, Frank Domino from Berlin Community School in regards to storing merchandise at the school. /Glory Day Sports has left volleyball nets for their games and will secure them at the center to be safe. /Basketball courts are roughly two weeks out per administrator. /Sign still being worked on for donors for the center. /Looking into key fobs for all doors at the center. /Recent problem with small damage at the center and we are trying to ascertain who is responsible.

PUBLIC SAFETY, Chairman Dennis Chance. Fire prevention night will be Oct. 5 at the community center. /Ambulance handled 184 calls for August (report attached to these minutes) Recalled 67 times out of those calls. /Police handled 32 motor vehicles accidents for August. 170 summonses were issued. (Report attached to these minutes. 1602 calls for month recovering \$3000 .worth of property. Traveled 9958 miles, arresting 9 adults and 1 drunk driver. Totals for the year to date for attached to these minutes.

FINANCE, Chairman Nick Maccaroni. Budget scheduled planning in all packets for 2012. Administrator and CFO will go over all budgets when presented in December.

SOLICITOR, George Botcheos reached out to PNC bank representative relaying the borough's position and they have not gotten back to him. Waiting for draft lease from Voice Tel for antenna site rental.

ADMINISTRATOR, Charleen Santora. Lease signed for the post office signed for 15 five year terms. /Halloween will be 10/31/2011 from 4 pm to 8 pm. /Quarterly safety meetings are being held with good attendance. All liability and workman's claims are turned over to the Fund Commissioner./Job posted on bulletin board for mechanic's position./All offices closed for Columbus Day./

Mayor stated that JIF Commissioner, John Saville, did a spot check on all borough facilities and report will be forthcoming.

Mayor also notes he met with DPW Superintendent from the Township of Berlin along with our own DPW Superintendent on the sharing of equipment on a continuous basis as they most recently did in lending the borough a pump when one of our pumps failed.
