MEETING CALLED TO ORDER BY MAYOR ARMANO.

FLAG SALUTE LED BY MAYOR ARMANO.

ROLL CALL: Mayor John J. Armano, Council President James Bilella, Council members Maccaroni, Scelso, Kupchik, Pearce and Knight. Councilwoman Kupchik was absent.

PRESENT ALSO: Solicitor George Botcheos, Police Chief Michael DeLorenzo and Administrator Charleen Santora.

DETECTIVE MICHAEL SCHEER WAS SWORN IN TO THE POSITION OF DETECTIVE SERGEANT FOR THE BERLIN BOROUGH POLICE DEPARTMENT. Michael Scheer's three children, Michael, Nicholas and Gabrielle held the Bible and Michael's wife Trish pinned his badge on.

CHIEF DELORENZO presented an Outstanding Police Officer Award to Patrolman Steve Palma. He received a plaque and was recognized for his outstanding efforts.

Police Chief DeLorenzo asked for council's approval on welcoming the new Data Clerk for the police department, Nancy-Geiser Tomko. Ms. Tomko was chosen out of 59 other applicants, she is a lifelong resident and speaks two languages.

Also, Chief DeLorenzo reported that the department has an officer out for about four to six months due to a severe injury. There is money allocated in the budget for the hiring of a Class II officer to fill the void and if there is no objection from council he would like to start the process. Council did not have any objections.

Councilman Scelso provided a report for the police department for the month of July 2014. The police department handled 1,993 calls for service. 291 summonses were issued along with 36 arrests, 4 DWI arrests, 20 warrant arrests and 22 drug arrests. 8,382 miles were put on the police vehicles during patrol and other duties. 29 motor vehicle accidents were reported with 6 resulting in injuries. A full report is attached to these minutes.

COMMITTEE REPORTS:

PROPERTY MAINTENANCE OFFICIAL, Robert Monahan reported that on New Freedom Road there is a private property that has dirt dumped in a large pile; a resident is complaining that her children keep going over to the dirt and they are playing on it. The private property on New Freedom Road is going to put "no trespassing" signs up. The resident complaining stated that it is illegal to have the dirt dumped on the property and she is going to provide the law or code to Mr. Monahan. When she does, Mr. Monahan will hand it over to Solicitor Botcheos for review.

MAYOR, John Armano reported that he is meeting with the redevelopment committee to discuss what help and or suggestions can be offered for two small businesses in town. He also is still waiting to have a meeting with the DOT to discuss issues on the White Horse Pike. On Wednesday (tomorrow) at 5:45 pm a solider that was deployed for 9 months will be returning home to 13 Jefferson Avenue if anyone on council would like to attend to greet him.

BUILDINGS & GROUNDS, Chairman Gary Knight reported that the library door needs to be repaired and it is going to cost \$152.00; the elevator at 59 S. White Horse Pike has been repaired; the brick steps in the front of the municipal building have been repaired and they will also have some reconstruction done on them which will be completed by Friday.

STREETS & ROADS, Chairman James Bilella spoke about the ordinance on the agenda tonight for adoption relating to the capital improvements on the municipal building. The Road Program for Malan Avenue is moving along; it is currently under construction and the trees are being removed.

WATER & SEWER, Chairman Lynn Kupchik was absent.

HEALTH & RECREATION, Chairman Jim Pearce reported that soccer has started. The opening ceremony will be held September 6th. Also, school is starting this week and last year residents were putting up barriers on Franklin Avenue due to parking issues. There is an issue on Presidential Ave as well relative to parking. There is a "pick up-drop off" only zone and on the other side of the street and the teachers park there. Due to the fact that there are only 5 school buses and most parents drive their kids to school, Councilman Pearce wanted to know if it was possible to have the teachers park in the community center parking lot during school hours. Police Chief Michael DeLorenzo will go and evaluate the situation on Thursday when school starts and he will talk to the Superintendent as well. Ultimately, Councilman Pearce would like for there to be restricted parking on Presidential and Franklin Avenue.

PUBLIC SAFETY, Chairman Scott Scelso provided statistics for the ambulance and for the fire department. The ambulance had 196 calls for the month of July; 96 of those calls were for Berlin residents. The fire company had 70 calls. Councilman Scelso reported that he will be meeting with special counsel to go over the police contract for next year on September 10th. Also, he met with Chief DeLorenzo about administering a notification system for residents if there should be an emergency in Berlin. The project will take time to put in place; once it becomes available to the public it will be beneficial.

FINANCE, Chairman Nick Maccaroni reported that the CFO is currently revising the budgets and transfers. Right now, the fire company is having a problem with their truck and the library has some shortcomings in their budget.

SOLICITOR, George Botcheos did not have anything to report.

ADMINISTRATOR, Charleen Santora reported that there is a bid opening scheduled for September 16th at 10 am for the Pipeline Rehabilitation project; RFP's will be received on September 24 for general banking services; as soon as Berlin Twp gets back to her about the ambulance budget split a meeting will need to be set up with the finance committee and the CFO; she is currently working on a liquor license transfer in regard to Venice Plaza – the application has been filed in the clerk's office along with the transfer fees. The applicants are in the process of getting their background check. There will be

two publications of this transfer in the Courier Post back to back as required by the ABC. A resolution will be on the agenda for council to approve possibly in October; Charleen has not yet put a spending freeze on, but she will ask anyone who has waited to purchase a mandatory item to do so within the next two weeks; two resolutions have been added to tonight's agenda relative to budget insertions for grant money received.
