Berlin Borough has been proactive since 2016. This new system has also assisted Waterford Township and Berlin Township with some of their sewer and water issues. Thanks' were extended to the whole team which consists of John Allsebrook, the DPW Supervisor, his team of employees, Lisa Eggert and Sharon Van Dyke the administrators in the Tax & Water Department, Hugh Dougherty from Pennoni Engineers and the Mayor and Council for supporting all of these projects.

Thanks were extended to Councilman Rocco, the Mayor and Council to helping to unite Berlin, as unity is the strength to unify objectives in Berlin.
