AN ORDINANCE TO RELEASE, VACATE AND EXTINGUISH ANY AND ALL PUBLIC RIGHTS IN AND TO VERMONT STREET AVENUE BEING MORE PARTICULARLY DESCRIBED HEREIN

WHEREAS, the Borough Council of the Borough of Berlin in the County of Camden, is of the opinion

that the public interest will best be served by abandoning, vacating, releasing and extinguishing any and all public

rights which said Borough may have in and to the following described portion lands known as Vermont Street.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Berlin, County

of Camden, State of New Jersey, as follows:

- All that certain tract or parcel of land, known as Vermont Street, also known as Block 501, Lot 3 1. and Block 502, Lot 19, as reflected on the Official Tax Map of the Borough of Berlin. situated in the Borough of Berlin, County of Camden and State of New Jersey, as more particularly described in Exhibit "A" attached hereto and made a part hereof.
- 2. The vacation set forth herein expressly reserves and excepts from said vacation, all rights and privileges possessed by any and all public utilities, as defined by R.S. 48:2-13, and by any cable television company, as defined in the Cable Television Act, P.L. 1972, c. 186, (C. 48:5A-1 et seq.), to maintain, repair and replace their existing facilities in adjacent to, over or under the street, highway, lane, alley, square, place or park, or any part thereof, to be vacated.
- All Ordinances or parts of Ordinances that are inconsistent with the provisions hereof, are, to 3. the extent of such inconsistencies, hereby repealed.
- 4. This Ordinance shall take effect upon final passage, adoption, and publication in the manner prescribed by law.
