PRIVILEGE OF FLOOR

COUNCIL AND DEPARTMENT HEAD REPORTS:

FIRE CHIEF William Behnke reported that the fire company has responded to 252 calls for service so far this year since January 2014. The number of calls for service has increased over the past two years. Berlin Fire Company has also been faced with some vehicle fires, accidents and small residential fires this year. The main reason why Chief Behnke is here at the meeting tonight is to discuss one of the fire apparatus's that is out of service. It is the 1993 ladder truck that is about 22 years old and so far \$12,000.00 has been spent in repairs. There is a water leak from the fiberglass tank and a company that makes the tank will determine whether or not or how to remove the tank which will be a substantial amount. Copies of photos are available for council to review. A nationally certified repair center is being used to take a look at the truck and the manufacturer of the truck will make the final call about how to proceed. Routine maintenance for all other trucks may be able to be put off until next year but the budget does include the costs for repairs and maintenance if so needed. Right now there are 48 active members in the fire company, 3 new fire fighters in the academy who will be graduating soon. The fire company is continuing to grow. Also, the Courier Post has selected Berlin Fire Company as one of the best in South Jersey.

PROPERTY MAINTENANCE, Bob Monahan reported on Maloney Avenue and the trees have been removed. Jiffy Lube has been an ongoing problem and he spoke with their property manager who is out of Texas and the property is getting spruced up and the trash can that has been getting extra trash dumped in there has now been secured and the car that was there is now back at KOP. 9 Hamilton Avenue is being addressed. A notice has been left there in the mailbox. 70 East Taunton received a complaint about debris and pallets in the driveway and it has since been removed. On Cross Keys Road there are trees between the White Horse Pike and Park Drive which is a property belonging to the Gerard Estate that need to be addressed. A letter was mailed to the contact person on the deed and the issues will be rectified. The vacant lot to next to Venice Caterers at 271 Cross Keys Road has knocked down fence and open gate with all kinds of debris. Spoke with mother's owner and she was receptive to getting the property cleaned up. Craig Fallstick and Bob Monahan visited the Kohler property located at 103 Wattonstown-New Freedom Road and the owner does have a warrant out for his arrest for not being in compliance and this will be taken to a higher level. 4 Glenside is a property that is going into foreclosure and there is a realtor lock box located there so he will get in touch with the mortgage company to take care of the issue in the back yard with the water that is covering the pool.

CHIEF OF POLICE Michael DeLorenzo provided a report for the month of March 2014. Six Class II applications are currently under review and interviews should take place at the end of May. The Department completed the Distractive Driving Enforcement Campaign on April 21st and 194 summonses were issued during the overtime campaign. "Click it or Ticket" statewide Seatbelt Enforcement Campaign begins May 19th thru June

1st and the amount received for overtime is \$4,000.00. The borough website has been updated and residents can now fill out house checks and firearms applications. A full report is attached to these minutes.

MAYOR John Armano reported that he received a call from the Governor's office and the borough is receiving \$195,000.00 in grant money for the 2015 Road Program. In regard to the interest arbitration cap - the assembly speaker is still holding that from the floor to be voted on so we are still up in the air with that. It is imperative that letters be written to the senate so that bill can be passed or it will have a negative effect on the budget process. Met with Good Energy and will ask them to come to council to put on a presentation to show how money can be saved from the gas and electric bill.

BUILDINGS & GROUNDS, Chairman Gary Knight reported that the air conditioner at 131 S. White Horse Pike is leaking and it needs to be fixed. Also, water came into the basement at 59 S. White Horse Pike from the rain and DPW is taking care of it. The old Berlin post office is being moved and will be placed behind the hotel.

STREETS & ROADS, Chairman Jim Bilella was absent.

WATER & SEWER, Chairman Lynn Kupchik reported that the water flushing is over in Berlin and the water is now clear. Flushing will be done again in the fall. Four bids were received for the camera I&I study and we will go with the lowest responsible bidder. Solicitor George Botcheos reviewed the bids and took a look at the statutes because the one company that submitted a bid noted that the prevailing wage act did not apply. George also spoke with someone in Trenton and the contract can be awarded. In the event that the cost of the repair work is over \$50,000.00 then the prevailing wage does have to be paid. Also, Councilwoman Kupchik spoke about resolution R5-14 relating to the change order for Well #15 which will be approved. There has been no final approval as of yet from the DEP on the Well.

HEALTH & RECREATION, Chairman Jim Pearce spoke about a \$1,000.00 donation that will be given to the community center from the Youth Elite Sports and Sara McHugh will come to a caucus meeting to present the check. They will donate a total of \$2,000.00. There also is another group that contacted Councilman Pearce about a donation for the community center. Discussed meeting with Canal's to discuss details for a fundraiser at the community center.

PUBLIC SAFETY, Chairman Scott Scelso reported that the police department handled 1,966 calls for service for the month of March 2014. 389 summonses were issued along with 51 arrests, 8 DWI arrests, 14 warrant arrests and 21 drug arrests. 10,267 miles were put on the police vehicles during patrol and other duties. 45 motor vehicle accidents were reported with 9 resulting in injuries. The fire department had 61 calls for service for the month of March and 47 calls for service for the month of April. The EMS had a total of 206 calls for the month of March and 111 were Berlin Borough.

FINANCE, Chairman Nick Maccaroni reported that the budget for 2014 will be voted on and he thanked the auditor and CFO for being here in case anyone has any questions. We have not touched the school deferred taxes since 2010 so we have been doing a good job of being self-sustaining. The hit to legal will be around \$15,000.00. Memorial Day services will be held on May 26th at the monument and for more information you can get in touch with Charleen.

SOLICITOR, George Botcheos discussed resolution 5-19;2014 awarding a contract for a municipal attorney which is a house keeping issue changing the name to a corporate entity.

ADMINISTRATOR, Charleen Santora reported that a resolution will be added to the agenda in regard to the click it or tick it campaign. Clerk's office has been very busy with animal licenses and citations and if anyone has questions they can call her.
