association that could help out with these problems. She explained that they were of no help and was told that parking is a common area. For every four parking places there are 35 cars fighting for these spaces. There are also to many people living in some units. Some units may have up to seven cars. This does not account for the renters, visitors and police cars that are parked there.

Mayor Bilella referred the resident to Councilman MacDonnell to try and come up with a plan to help with this situation.
