WHEREAS N.J.S.A. 10:4-18 provides for "ANNUAL NOTICE," which means at least once each year, within seven (7) days following the annual organization or reorganization meeting of a public body, every public body shall adopt, post, and distribute a schedule of its regular meetings for the coming year. The schedule must contain the date, time, and location of the meeting. Also, it shall be mailed, emailed, faxed, or hand-delivered to at least two (2) newspapers which shall be designated by the public body to receive such notices,

Formal action will be taken at all Regular Meetings. Public comments will be permitted at designated periods during all meetings. Executive Sessions, which are closed to the public, may be held to discuss matters authorized for closed sessions under N.J.S.A. 10:4-12. Before each Executive Session, the Borough Council will convene in open session, at which time a resolution will be adopted under N.J.S.A. 10:4-13 to enter into closed session. Regular, Workshop, or Special meetings may be adjourned, rescheduled, or held on different dates providing such are duly noticed as provided by law.
