• BUILDINGS & GROUNDS, Chairman Len Badolato

In the last council meeting Councilman Badolato covered eight items that he would like to accomplish in the upcoming year. At present, he is waiting for the budget to be finalized before he moves forward with any of these projects.

• <u>STREETS & ROADS</u>, Chairman Dan MacDonnell – No report

• WATER & SEWER, Chairman Ron Rocco

Statistical Reports for the month of January 2017 were given for Water & Sewer Income. There were some calls about dis colorization of water on Glenview, Park and London Ave. This problem was addressed immediately. The repair on Rt 73 North was and the defective values replaced at well 2. Well 1 has been painted and is now completed. There were sewer blockages on Holly and West Main & Taunton. All these areas were fixed. The maintenance of all sewer pump stations was completed and we currently have a special water projects out for bid.

• HEALTH & RECREATION, Chairman Michael Buchanan

The upcoming Rabies Clinic is scheduled for April 1, 2017 at the DPW station. We are looking into upcoming dates for a community cleanup day. We are looking at the area around the jug handle to start. Please contact Michael Buchanan if you see other areas in town that are in need of clean up. A meeting is scheduled on March 1, 2017 to discuss the current parking ordinance. A community meeting will then be scheduled for the residents. The community center will now be available as an open gym on Fridays from 4-6. This is for 30 plus and young people who would like to use the facility. We are currently in need of an attendant for these hours. If you know of anyone that would be interested, please contact Michael Buchanan for more details.

• PUBLIC SAFETY, Chairman Jim Pearce

Tonight, we will be swearing in Detective TJ Varano. The fireman's installation Dinner was a well-attended function. All of the Governing Body members were present. The Borough was presented with a plaque in thanks of helping them to obtain their new ladder truck. The plaque also includes a picture of the new truck and is now hanging in the hall outside of the court room.

The statistics for January 2017 for the police department were read.

• FINANCE, Chairman Rick Miller

Community Champions helped the borough to collect past due foreclosure fees of \$6900.00 on a total of 23 properties.

Councilman Miller has contacted the County about the trash along Cross Keys Road. It has been reported that there are blue medical gloves scattered along this area.

The upcoming Easter Event is being planned and scheduled on April 9th from 2-4 at the Borough Hall.

MAYOR, Jim Bilella-

Mayor Bilella gave a brief report on Streets and Roads for Councilman MacDonnell. He gave an overview of the completion of Clementon Road Project Phase I & II. He stated that before Phase I & II, there were approximately 20 -25 accidents per year along this road. After its completion, there have been no accidents reported along this road. This area is considered a school safety zone where some children are required to walk to school and we are very proud to see that the new configurations of this road have been successful. During our reorganization meeting we implemented Phase III of the Clementon Road Project. Phase III will involve adding sidewalks to developments and areas where they are needed. Clementon Road is a county road and we are currently waiting to receive approval so we can move forward with Phase III. We are planning on having the sidewalks complete by the Summer of 2017. You can't place a value on a child's or person's life, that's why we are placing safety first because this is where we have control for the residents of our community.

The Borough and the NJ State League of Municipalities is encouraging high school Juniors and Seniors in the borough to apply for a \$1000.00 scholarship to use towards there college education. There will be more information and details upcoming on our borough website. There will be three winners at the state level. This is a great opportunity for our students to compete.

There is a resolution on tonight's agenda in relationship with the COAH agreement. This agreement is also known as the Mt. Laurel Decision. Detailed explanation of this agreement and COAH were discussed. The boroughs Fair Share Housing quota has been filled and we are now in compliance with the state until 2025, meaning no additional housing requirements need to be built until the fourth round in 2025. We were the first town in the County to meet compliance.

Council has an opportunity to maintain open space in the Borough. The area known as Simon Family Farms, which is zoned R-2 development and would be considered for high density housing. Over 90 units could be built in this location but Council has moved forward with keeping it as open space. Simon Farms, The Berlin Farmers Market and the Borough have negotiated to purchase part of this land to keep as open space. The other part will be purchased by the Berlin Farmers Market and zoned commercial. The front part of the property will be maintained as open space.

Currently the Council is pushing for re-development in the borough. Budgets are tight and we don't want to raise taxes. There is a limit to how much we can spend and can't. Budgets can't be cut enough before you have to raise taxes and we have necessary services for our residents that must be maintained including Police, DPW & Municipal Employees. Our Fire

Company is entirely volunteer. We fund their services which we work into the general budget and don't have to pay taxes for a separate fire district.

Redevelopment is the only way to raise our tax base and raise revenues. We need commercial taxes. The K-Mart Sopping Plaza has been in foreclosure for many months. It is owned by Armstrong Capital. At this time, all of the properties owned by this company are in foreclosure. It is taking longer than they thought to resolve. They had hoped this process would have been done by December of 2016, but the case is very complex. Sterling Bank received judgement against the owner for over 5.4 million dollars and is now moving forward. This property must be on the market for four weeks and they are currently looking for developers to purchase this property. If they find an interested party before the foreclosure process, they will gladly sell ahead of the foreclosure process. The Mayor is currently working with the bank and the mission is to make Berlin the Center of Commerce in New Jersey.

• PRIVILEGE OF THE FLOOR

Joe Theurer 21 Coleman Ave Berlin, NJ 080009

Mr. Theurer asked if Nexus and Armstrong properties were owned by the same company? Mayor Bilella said they were owned by two different parties. Mr. Theurer also wanted to know what is going to be done in reference to traffic control on Tansboro Road. The Mayor explained that currently the design and engineer are working through this problem.

Councilman Buchanan mentioned that the Berlin Soccer Club who utilizes the Franklin Ave Fields is entering into the Round II of applying for the grant. It is due by March 31. He wants to talk more to the Mayor and Chief Miller about this issue.

Bill Bansch 79 New Freedom Road Berlin, NJ 08009

Mr Bansch stated that he is a part time employee of Berlin Borough. He addressed Council and our Borough Solicitor and asked what can be done about the recent face book allegations that have been posted about our governing body. He said that what is being said is slander and should cease to exist. The Borough Solicitor, Howard Long said that because this is a private sight and under the first amendment freedom of speech, there was nothing that could be done.

Donald Falk Downtown Revitalization Committee Member Board member - Treasurer

Mr. Falk explained the goal of the DVRC. He stated that revitalization of the down town area and renovations are not being paid for with tax payers money. They are being funded by the owners of the property.

He commented that it is very easy to sit behind a monitor and key board but because of the 1st amendment freedom of speech amendment we have no recourse in what is said on this sight.
