#### • BUILDINGS & GROUNDS, Chairman Len Badolato

#### • STREETS & ROADS, Chairman Dan MacDonnell

- The 2017 Road Program on Constitution Blvd. is almost complete. They will be installing the speed bumps next week.

- We will be receiving an authorized street plan for the next five years from our engineer within the next two months. We will also be informed within the next few months of the grant money amount we will be receiving from the state for the upcoming 2018 Streets and Roads Project.

#### • WATER & SEWER, Chairman Ron Rocco

- The Water Report from DPW was given including the number of service calls on water meters, areas which needed maintenance, water main breaks, leaks and total number of water shutdowns and locations for the month of November.
- The Sewer Report was read along with maintenance reports on pump stations, generators and sewer blockages and locations for the month of November.
- The 2017 vs. 2016 Tax Report for total income received for utilities was read. This report also included the total number of water and sewer connections.
- There were no water complaints for the month of November.
- In January, I will be attending a forecast meeting to discuss the upcoming projects of 2018.
