COUNCIL REPORTS:

• BUILDINGS, PARKS, & RECREATION, Chairman Len Badolato

- <u>Painting Rebid</u> -The hotel section of the library will be going out for rebid again. We only received one bid the first time and it was over our allocated funds for this project. The Certificate of Availability of funds for this project are not to exceed \$70,000.00.
- <u>ADA Compliance</u> -The Borough Hall parking lot is not compliant with ADA standards. We are going to repaint the parking spaces to meet the requirements.
- <u>DBRC Meet & Greet</u> -The DBRC will have a meet and greet at Lucien's on May 23rd at 6:00 pm. They will go over their goals and plans for the center of town.

• PUBLIC WORKS, STREETS & ROADS, Chairman Dan MacDonnell

- <u>2017 Road Project</u> will be completely finished in a few weeks
- 2018 Road Project We are in the finalization of the design phase of the 2018 Road Project. We want to go out to bid on this project in June, award in July and start in late August early September. We are receiving double the amount of money compared to last year because of the gas tax. We will be doing a traffic study from White Horse Pike and all of the adjacent side streets. We will also conduct a meeting with residents on these streets to get their input and suggestions on how to slow traffic down.
- <u>Jackson Road</u> The County will be starting road work on Jackson Road towards the end of Berlin. The road will be closed, so an alternate route should be taken.
- <u>Planning Board Meeting</u>- The Planning Board meeting for Monday has been cancelled because no applications were submitted.

• WATER & SEWER, Chairman Ron Rocco

- Water & Sewer Reports were read for 2017 vs. 2018. They included income, connections, routine maintenance and replacements needed to all wells and pump stations.
- <u>Hydrant Flushing</u> is now completed and we had minimum water complaints during this process in April.
- Water Accountability Act -The Borough and our Public Works Supervisor, John Allsebrook are working with Hugh Dougherty, our engineer to plan how the borough will be meeting the new mandatory standards of The Water Accountability Act. The state will be requiring every municipality in NJ to meet and be accountable to these standards.
- <u>SCADA</u> The training of DPW workers on the SCADA system, is almost complete. They will begin using the robotic system on May 31st.

- <u>Social Media Recognition</u> goes out to Councilman Miller. He is doing a great job informing our residents with up to day information. For example: On May 12th there was a hazardous conditions alert and also a delay in the trash pickup. He posted these issues on our website to update our residents.
