Councilman Badolato, Camp long-a-coming is up and running. The camp be going from July 8 until the 15th of August. And last year there were 159 campers. This year there we have 188. Last year the camp brought in \$41,145. This year it brought in \$50,950. These numbers show how important these programs are for the Borough.

Tim Trout from BCS will be having their band practice at the Dill House in the month of July. They will be in there from 12:30 to 330 every day.

Councilman Badolato wants to report on the train station. He states it's the oldest standing train station in the State of New Jersey. There is going be work starting to replace the planks on the deck. They are in bad shape. This will be happening the last weekend of July and that's going to be done by the boy scouts and funds coming for that. Councilman Badolato thanks the boy scouts for getting involved.

Councilman Mascarenhas gives updates on the 3 Berlin Parks that are being redone. He states that they have begun taking down the Bel Air Park. Councilman Mascarenhas says the hopes are that are 3 parks are started by September.

Councilman Mascarenhas thanks the staff and Borough Administrator , Anne Marie Miller for her help.

PUBLIC WORKS, STREETS & ROADS - Councilman Wilkinson and Councilman Cummings

Councilman Wilkinson states the 2024 road program for Laurel Woods, Monterey Court and Blatherwick is set to go out. It's in a design phase and it's going out for bid in the fall of this year.

Councilman Wilkinson states they are currently going over the 2025.

Councilman Wilkinson states he has no new updates on the Crosskeys Road Project.

> WATER & SEWER - Councilwoman Cummings and Councilman Badolato

On June 28th, the department was found to be 100% in compliance with all of our department rules and regulations concerning our water allocation permits. The Borough had 15 service orders for meter repair and replacements that were completed 83 utility workouts and monthly maintenance on the water plant was completed for sewer. The Borough completed all of our routine monthly maintenance there as well with our 10 emergency backup generators at the sewer pump stations. The latest update on the emergency generator on Crosskeys Road is we have that for delivery is now July 31st.

- ➤ Councilwoman Cummings explained that the water rates were being increased from \$3.60 to \$4.40 per 1,000 gallons quarterly for residential usage up to 10,000 gallons to cover the costs of infrastructure improvements.
- Mr. Long mentions that the Borough's water rates are significantly lower than those of New Jersey American Water Company. Mr. Long also mentioned that there would be a sewer rate increase.

### Short-term rental property regulations

Mr. Long explained that the new ordinance aimed to regulate short-term rentals like Airbnb to address issues like noise, trash, and overcrowding caused by some problematic properties while still allowing responsible short-term rentals. Mr. Long provided details on the registration process, fees, and enforcement mechanisms for short-term rentals.

Mayor Miller thanks everyone for their help and involvement with the 4<sup>th</sup> of July Parade. States how nice it is not to have to worry about anything , and it just gets done.
