> BUILDINGS, PARKS, & RECREATION Councilman Badolato and Councilman Mascarenhas

Councilman Badolato introduced representatives from Triad Associates, an organization that helps with economic development and securing funding for projects. The Triad representatives explained their approach of creating a project and funding matrix to match priority projects with available funding opportunities. They suggested starting the process by having department heads provide their priority project lists, which Triad can then use to identify potential funding sources and required matching funds.

Councilman Badolato thanks Stella's Farm for providing the cornstalks.

Councilman Badolato also states that he took part with the DBRC with the South Jersey Breast Cancer Coalition.

Councilman Mascarenhas states the Borough is starting the process for the park in the Woods Development. The Borough is adding more specialized equipment over to Centennial Park because it's a big property.

PUBLIC WORKS, STREETS & ROADS - Councilman Wilkinson and Councilman Cummings

Councilman Wilkinson gives updates on upcoming path work and holiday lighting preparations by the Department of Public Works. They discussed adding specialized equipment for children with disabilities at the parks and the possibility of securing matching funds for these projects.

WATER & SEWER - Councilwoman Cummings and Councilman Badolato

Councilwoman Cummings states the Borough had 18 service orders for meter repair and replacements were completed. 76 utility mark outs were completed for the month. Monthly maintenance on both water plants was completed and replaced 10 water meters.

Councilwoman Cummings states the notices for meter replacements that previously had issues were regarding the notices with the shutoffs, everyone is now complying with that. The Borough has almost completed the water meters. The Borough has also started, the prepping the water tower for the painting project.

The Borough has completed all routine monthly maintenance at our 10 pump stations. Monthly maintenance on the 10 emergency backup generators at the sewer pump stations has already been completed and replaced the high-level flow at the enclave pump station.

PUBLIC SAFETY – Councilman Hohing and Councilman Mascarenhas

Councilman Hohing goes over the monthly numbers for the September reports. The EMS for the Borough of Berlin had 126 rollouts. It was roughly 48% of Berlin Township had.

The Berlin Fire Company respond to 66 calls for service in September, 649 total for 2024.

Comparison in numbers in previous years of September, last year was 90 versus 66 this year.

The Borough Fire Department received training on Tuesday nights and included the hauling system training, rescue, rope training, fire prevention and apparatus maintenance, staff, weekly, daily, daily time duty crew and during those hours ready to respond to calls, review an inspection, check apparatus, all means of cleaning and extra training along with the above activities. The Borough Fire Company hosted fire prevention night which several of the council were there.

Councilman Hohing states he was in attendance and says it was a really, nice and beautiful evening at the at the community center and also went into the schools to teach your Children the importance of safety, the interaction with the community, Children and prices and forces the bond makes Berlin Borough a great place to live. And as always on behalf of the volunteers, Councilman Hohing personally thanked them and the governing body for continued support on behalf of our police Chief Michael Kernan.

The Berlin Borough Police department had 90 searches for vehicles involved in criminal activities compared to 7540 summonses for tags issued compared to 88 and 22 traffic stops compared to 45 community policing. Various officers participated in fire prevention, night out bicycle safety course at BCS was held on October 9th and the Fall festival is scheduled for this coming Saturday. Canine Clyde had mandatory in service training on 9/26 and four total police vehicle stops resulting in two arrests and possessions of suspected narcotics related drug paraphernalia.

Patrolman Palma was named the officer of the month for the foot pursuit of subsequent address of a male. One for the theft of a of a \$15,000 worth of fiber optics. Another note here is the railroad of Washington and McClellan will be closed for upgrades from the October 11th to the 18th and Harker Avenue railroad is estimated to be eliminated by October 21st.

Mr. Longs explains the introduced Ordinance 2024-19, appropriating \$130,000 from the capital improvement fund for the purchase of a fire quick response vehicle. The council introduced Ordinance 2024-20, prohibiting certain acts for carrying, using, possessing, or discharging dangerous or deadly weapons in the courtroom, as required by the administrative office for court security. The council introduced Ordinance 2024-21, amending Chapter 315 regarding vehicles and traffic, and Ordinance 2024-22, amending Chapter 28-1 and Chapter 335 to add certain properties to the historic district.
