Introduction and presentation by Girl Scout Abby Miller

Abby Miller, a senior Girl Scout, proposed her Gold Award project to make the history of Berlin more interactive for younger children by creating period costumes, activities related to historical professions, and portable educational materials. She aims to have the project completed by February and piloted with a 4th grade class, with the materials kept at the Dill House for use in presentations and school visits. The project requires at least 80 hours of work and a final report to the Girl Scout Council to officially receive the Gold Award.

BUILDINGS, PARKS, & RECREATION Councilman Badolato and Councilman Mascarenhas

Councilman Badolato reported on park cleanup efforts, including work at Berlin Park by Camden County and volunteer work at the train station. The Berlin Hotel was nominated for the National Register but needs revised paperwork for historic significance criteria instead of architecture. Plans are underway to replace missing gingerbread trim on the Berlin Hotel with assistance from a local company.

Stormwater management program with Rutgers University

Councilman Badolato met with the Pinelands Preservation Alliance about a grant-funded program with Rutgers University to provide guidance on stormwater runoff management for residents and the community center. The program offers webinars, property assessments by experts, recommendations for plantings and landscaping, and rebates up to \$650 for implementation. Representatives will be invited to present the program details at the next council meeting.

Councilman Mascarenhas gives parks updates.

Three parks are up and running, with Centennial Park to be finalized with additional specialized equipment. maintenance, pump replacements, and an upcoming mandate to identify and replace lead service lines by 2031, for which letters will be sent to residents.

PUBLIC WORKS, STREETS & ROADS - Councilman Wilkinson and Councilman Cummings

WATER & SEWER - Councilwoman Cummings and Councilman Badolato

The water department provided updates on the chestnut tank painting repairs, water conservation advisory, hydrant quick connect installations, new truck delivery, meter repairs and replacements, and routine maintenance. The sewer department reported on pump station maintenance, pump replacements, and an upcoming mandate to identify and replace lead service lines by 2031, for which letters will be sent to residents.

Councilwoman Cummings states residents that are by the chestnut tank may experience some lower water pressure, a slight, decrease temporarily until that is back up and running.

> PUBLIC SAFETY – Councilman Hohing and Councilman Mascarenhas

3025 total calls per service which is down from September, we have 144 summonses, compared to 322 in September, 31 arrests for October, compared to 18 in September. The Borough had 28 motor vehicle accidents this month. There was 92 traffic stops compared to 189 in September, Tag readers read 757,704 total license plates compared to 631,818 in September.

Councilman Mascarenhas also reported on the fire department's activities, including responding to brush fires in surrounding towns, receiving training, and being overlooked for their hard work.

YOUTH ATHLETICS AND COMMUNITY EVENTS- Council President Miller and Councilman Wilkinson

Youth athletics and community events

Mayor Miller mentioned that the Borough had received a wish list of items from Berlin A.A. for maintenance and improvements, and that the CFO had some extra money in the capital budget to address those needs. Participants discussed the possibility of involving the school board in maintaining the youth athletics facilities and the importance of investing in such facilities for the community's youth.

> FINANCE - Council President Miller-

Council President Miller thanked the residents for their votes in the recent election and expressed their commitment to working hard for the community. Council President Miller made several announcements, including the grand opening of a business, the Rotary Club's plans to put up Christmas lights, and the fire department's tree sales. Council President Miller also mentioned meeting with a representative from the assemblywoman's office to discuss the borough's concerns and needs.
